## **Covid-19 Pool Guidelines 2020 Pool Season**

To reduce the risk of spreading or contracting Covid-19 at our pool, we have provided the following guidelines. **It is imperative that any residents who decide to use the pool this season follow these guidelines.** If we are unable to follow our guidelines that are aligned with published guidelines from the Cobb County Public Health Department, the Georgia Department of Public Health, and the CDC, our HOA Board may be forced to close the pool.

- 1. Most importantly, please realize per the CDC recommendations that "if you or anyone in your household is experiencing symptoms of COVID-19, you should stay home until the CDC's published isolation criteria are met".
- 2. No visitors/guests are permitted. The pool is to be used by Cameron Glen and Cameron Park residents only.
- 3. Maximum pool/pool deck capacity shall be 25.
- 4. Hand Hygiene and Respiratory Etiquette

We encourage all patrons, and swimmers to wash their hands often and cover their coughs and sneezes.

# 5. No Tables or Chairs will be Provided

No tables, chairs, or umbrellas will be provided. If you wish to have any of these, please bring your own. When you leave, you also need to take home anything brought to the pool. **Please do not leave any personal items at the pool when you leave as they will be discarded.** 

# 6. Disinfect the bathroom BEFORE and AFTER your family's use

Protect yourself and your neighbors by cleaning the bathroom before use, including knobs, handles, and bathroom surfaces such as sinks, counters and toilet seat and handle, and clean once again after your family's use. Residents must supply their own cleaning supplies.

# 7. Wipe Down Common Areas

Upon leaving the pool, we are asking residents to be sure to wipe down and clean common, hightouch areas. Specifically, the handrails and ladders into the pool, as well as the pool gate. Residents must supply their own cleaning supplies.

# 8. Practice Social Distancing

Stay at least 6 feet away from your neighbors both in and out of the pool. You can decide how close you are to those that live in your home.

# 9. Masks or Coverings are Recommended

Consider wearing a mask or covering over your nose and mouth while <u>**outside**</u> of the pool. <u>**DO NOT**</u> wear a mask while in the pool.

#### 10. Do NOT share toys, floats, goggles, snorkels, etc.

Please do not share items with others who do not live with you.

# 11. The drinking water fountain will be covered and unavailable.

# 12. No one under the age of 18 is allowed in pool area unless chaperoned by an adult.

## 13. In the event of Covid-19 Exposure

Please notify <u>harryeprice@gmail.com</u> if you or a family member have visited the pool within 14 days of testing positive for Covid-19. Should the board be informed that a resident, who visited the pool, tests positive for Covid-19, we will need to close the pool for at least 2 days. An email will be sent to notify residents of the exposure.

#### 14. Reserve your time on Sign Up Genius

We are using Sign Up Genius and it is available for residents to access and <u>reserve your time</u> at the pool. Visit our website for details. Our goal is to have a schedule available at least a week in advance to allow residents to reserve their time. This allows you the comfort of knowing when you can enjoy the pool and knowing that we are able to reduce the number of residents at the pool enabling everyone to practice social distancing <u>IN</u> and <u>OUT</u> of the pool. Please refrain from booking the same spot throughout the week or across multiple days.
