TENNIS COURT RULES & REGULATIONS

Following are the general regulations, reservation and courtesy rules for residents and their guests who utilize the tennis courts. The Cameron Glen Homeowners Association, Inc. ("CGHOA") strives to maintain the quality of the courts and the appearance of the grounds around the courts.

These efforts by the CGHOA and the resident's compliance with these rules are intended to help make the sport of tennis more enjoyable.

Regulations & Courtesy Rules:

1. All tennis court rules, regulations and courtesies shall be observed.
2. Tennis courts are to be used for tennis only. No bicycles, skates, skateboards, in-line skates, hockey or other activities are permitted.
3. No pets or animals are allowed on the courts.
4. Tennis shoes are mandatory. Appropriate tennis attire is suggested.
5. Food, gum, tobacco, and glass containers are not permitted inside the fenced court area.
6. Please place any trash or debris in the receptacles provided around the court area.
7. Weather permitting, the courts will be open from 7:00 a.m. until 10:00 p.m.
8. The courts are lighted and are on a timer. When leaving the courts at night, please turn the lights off.
9. Lock gates after use.

Reservations:

The tennis courts are in great demand. Fair use depends on the efforts of all that play. The CGHOA requests your cooperation in observing the following rules when reserving the court:

1. Residents may reserve the tennis courts by using the website. In general, reservations should not exceed a two-hour period for singles and/or doubles play.
 2. When reserving a court, please visit our website at <https://cghoa.site/> go to the "Residents" menu, then select "Reserve Tennis Courts"
 3. To avoid "no show" court time that could be utilized by others, please "Cancel" your reservation as soon as you can so that it may become available to someone else.
 4. A Resident may extend the use of the courts to no more than three (3) guests at a time. The member must be present on the same court when such guests are playing tennis.
 5. If no player arrives within 10 minutes after the start of the hour reserved, the reservation is void. The court becomes available on a first-come basis for the remainder of the hour.
 6. ALTA Team game day and practice reservations have priority over all other reservations. Any other league games (K-Swiss, USTA, etc) have priority over any recreational or personal reservation. For all other reservations, the "First Come First Play" rule will apply.
 7. Recreational or personal usage must stop 15 minutes before ALTA Team games and practices are set to begin. Individual league games (K-Swiss) must be scheduled to begin at least two (2) hours prior to ALTA Team practices.
 8. Team practices and matches must be scheduled well in advance and for the entire season.
 9. ALTA make-up matches are time sensitive and may be scheduled over previously indicated reservations. However, the team captain must notify the person who previously scheduled playing time 24 hours prior to the scheduled time slot.
- Any violations of the tennis court rules may result in the denial of access and/or tennis membership privileges by action of the Board. Any person found using the facility for purposes other than its intended use (playing tennis) will be held responsible for any damages to the area, including the surface. Charges will be made to the Association member.
